Release of Liability, Photography Release, and Acknowledgement of Tuition Policies

Release of Liability

I waive all rights and release all claims that might be had against Metropolitan Ballet of Tacoma, henceforth referred to as MBT, its hired or contracted instructors, and their employees and agents, for any and all injuries or losses which may be suffered because of my participation or my child's participation in any or all enrolled activities within MBT. I also realize that dance requires hands-on instruction for proper body placement and development of muscles.

Release of Photography and Information

I give permission to have my child's photo taken during activities and used for publicity purposes by MBT and/or Red Letter Moments Photography. I consent to the use of my child's name, image, or voice in any publicity contracted by or used by MBT or Red Letter Moments, including video taping.

Emergency Treatment

I consent to my child's participation in activities/programs registered for and authorize MBT and its employees or agents to provide or secure emergency medical treatment for my child on my behalf. To the best of my knowledge, my child does not have a physical or other condition which would interfere with participation in MBT's program.

Tuition and School Policies:

A \$25.00 fee will be charged on all late or returned checks. Payment due dates are included in the school brochure. For each additional week, a late fee of \$10 per week will accrue until the balance is paid in full.

Costume and Recital Fees For each performance, a non-refundable costume and recital fee will be due to help cover the costs of cleaning/buying costumes, printing programs, rehearsal time, and contributing to set and lighting costs. Please see the fee schedule in the school brochure.

Tuition is due the first lesson of each session unless a monthly payment schedule has been arranged. Monthly payments will be considered late by the 6th of each month. There is a 10% discount on tuition for families paying the full year amount by September 30th. Not applicable with any other discount.

5% Discount for families with more than 1 student, 8% with more than three. Not applicable with any other discount.

There is no drop in fee for school and company classes. Most adult classes offer a drop in fee of \$15 per class. See the school brochure for specific prices.

A full tuition refund (excluding the non-refundable \$20 registration/insurance fee) will be given before the session begins, or a 50% refund 2 weeks into the session. Thereafter, we regret there will be no refund.

Missed classes due to illness or weather cancellations may be made up by rescheduling with the Director of the School Division. No refunds.

Company Expectations In order to be a part of the Company at MBT, we expect dancers and families to commit to the policies and expectations including attendance, dress code, and participation in all rehearsals and company events. Each company member and family will be asked to sign a Company Agreement Contract.

I have read and I accept the policies explained in MBT's school brochure and on this sheet. I also understand that I am responsible for the full tuition due for all sessions, and am responsible for any fees accruing because of late or returned payments.
